President's Message

September has rolled in along with school buses and a new year of activities for the West Laurel Civic Association. Our first event was held this week, with presentations from the 9-1-1 dispatchers and **Corporal Beasock** (West Laurel Community Officer/District VI). On hand to answer questions were **Officer Colleli** (Park Police), **Chief McLaughlin** (Laurel City), **Major Brewer** and **Officer Johnson** (District VI) and **Brian Moe** (Director of Homeland Security, Prince George's County). Critical tips included: if you call 9-1-1 and get put on hold, do not hang-up as they have to call you back; cell

phones do not always provide accurate location and your call can be misrouted to the wrong 9-1-1 call center; and if you use a Voice Over IP (VOIP) phone, your address may not be accurate. Coming up are the General Meeting on October 27 with **County Executive Rushern Baker**, and Dumpster Day on November 5.

I, along with many of the WLCA Board Members and residents, continue to work on ways to make West Laurel a community that allows seniors to age in place. Board Members **Jason Float** and **John Hebert** have kicked off a special

Fall General Meeting

The Fall West Laurel General meeting is scheduled for October 27 at 7:30 PM and will feature a community discussion with **Prince George's County Executive Rushern Baker** and **County Councilwoman Mary Lehman**. This is your opportunity to ask questions, provide inputs on current initiatives, and have your voice heard.

Inputs for questions include: Why doesn't code enforcement work? What is happening with Dimensions Healthcare and the Laurel Hospital? Why hasn't Prince George's County put into place

strong environmental programs such as credits for rain barrels and rain gardens as Montgomery County has? When is Prince George's County going to provide a transfer station in the Northern area of the county instead of making us drive to Upper Marlboro? Why can't Prince George's or Montgomery police cross county lines to answer 9-1-1 calls? After promising to add transparency to the zoning process, why has Mr. Baker appointed a leading development attorney to lead the planning board and proposed moving selected zoning oversight from

West Laurel Housing Values

This year, 2011, continues to be slow in real estate. From January through the beginning of September, only 33 homes have sold in West Laurel, all in Prince George's

County. The average price has dropped approximately \$40,000 from 2010. The chart below shows home sales from 2008 to the present for all homes sold in Montgomery County and Prince Geor-

ges County. It does not include no-cost property transfers or unimproved property.

DUMPSTER DAY!

On Saturday, November 5 from 8:30 AM to 12:30 PM, the West Laurel Civic Association and the Prince George's County Department of Environmental Affairs, Waste Management will sponsor another dumpster day at the West Laurel Community Center. Residents are invited to come to the front parking lot to unload their junk into two 3-ton dumpsters. The dumpsters are open on a first-come/first-served basis. When both dumpsters are full, no further articles will be accepted. Hazardous waste and electronics will not be accepted.

Residents who wish to discard electronics should go to BEST BUY in Laurel. The store accepts small objects at no charge. Larger objects are also accepted but a \$10



charge will be assessed for each item. The customer is then issued a \$10 gift card for each \$10 paid.

Beasock's Beat

When Commander Brewer wants to know what is happening in West Laurel, he summons me because in addition to being a patrol officer, I am also a community officer, and West Laurel is my beat. I keep my fingers on the pulse of this neighborhood. It is my duty to not only patrol the area but also to act as liaison between the police and West Laurel residents.

It is my duty to educate you so that you can join forces with the police to keep your community crime free. Is this a monumental task? Yes, but when we work together we can accomplish great things. Listed below are ways in which we can all work together.

Be proactive. For two years, I have stressed the importance of police home inspections. The inspections only take about an hour and many of the changes that I suggest are low-cost and easy to accomplish. Some residents have taken advantage of this but I wish more would come forward. Schedule your home inspection by calling me at my office in Beltsville at 301-937-0910 or e-mailing me at jwbeasock@co.pg.md.us.

Another way to be proactive is to fill out an inventory list. I have posted one on the West Laurel Yahoo group. If you don't have this list, make up your own. It is important to list the serial number, make and purchase price for all electronics. This is a big help to me if your items are stolen. Also separately list all items of value in your house. A picture of each item is also helpful. Please don't forget to take anything of value out of your car and lock your car upon exiting.

Attend Neighborhood Watch Meetings. Corporal Knight and I

are willing to discuss recent crimes with concerned citizens. We also invite speakers to our meetings to answer questions that you have. In September, Neighborhood Watch hosted a meeting with a 9-1-1 dispatcher. Many questions were answered that evening. In the coming year, I am sure we will have more speakers of interest to you.

Participate in family walks and bike rides. This is West Laurel's way of demonstrating to everyone the support your neighborhood gives to me and my colleagues. This is our way of announcing to

criminals that West Laurel is serious about reducing crime and residents have formed a solid partnership with the police. You should report suspicious activity when you see it and be vigilant in watching out for fellow residents. We are determined to assist community youth in growing up to be useful and productive adults.

Yes, West Laurel is my beat and I am proud to be a part of this community. In the two years that I have been your community officer, we have accomplished much, but there is still much to do. ❖

Neighborhood Watch

C rime in West Laurel is low and to keep it low, your participation in Neighborhood Watch is needed. At the September Neighborhood Watch meeting, **Corporal Beasock** presented statistics on crime in our community from January 1 to the present. There have been seven thefts from autos and nine break-ins, including three at the end of the summer. We also had several vandalism incidents over the summer but all in all, West Laurel is doing well.

As Corporal Beasock states in his column, we need to continue to show our presence through sponsored walks, reviewing our own home security, and staying alert. There are times when a community should band together to protect all citizens and there are times when we should stand aside and allow professionals to do their job.

Initiating new laws for protection of citizens is the responsibility of all citizens. It is our responsibility to let our elected representatives

know how we feel about issues affecting us about crime. These elected officials should listen to their constituents and enact new laws for our protection. An example of this is cyber bullying. The state of Maryland does not currently have laws against cyber bullying. As we have seen in the news many are hurt by the practice and some are driven to commit suicide. Join Neighborhood Watch in petitioning our elected officials to rectify this shortfall.

In West Laurel (Prince George's County), law enforcement is the responsibility of District VI Prince George's County Police, led by our community officer, Cpl James Beasock (jwbeasock@co.pg.md.us). Montgomery County's community liaison is **Officer Joy Patil** (Joy.Patil@montgomerycountymd.gov). Incidents at the West Laurel Community Building fall under the Park Police, and activity at the boat launch and along the river is under WSSC Police. It is not the respon-

West Laurel working group on how to provide outreach to seniors. **Beth Evans** continues to spearhead our Neighborhood Watch program which hosted a terrific children's event this summer, Biking with Beasock. **Bryon White**, our in-house traffic and safety lead, has recently been asked to serve at the county level in this capacity. **Tony Spezio** continues to head our membership team. These are just a few of our activities. If you have an idea for an outreach program and wish to volunteer, please contact a member of the board — we're always looking for new people to increase our reach.

Last May at the General Meeting, WSSC presented its alternatives for the new pipeline which was straight through the middle of West Laurel. After several follow-up meetings with WSSC and **Senator Rosa-pepe**, **Delegate Pena-Melnyk**, **Councilwoman Lehman**, and the WLCA, we were unsuccessful in identifying an alternate route for the new pipeline. It is currently slated to start at the dam, progress along Brooklyn Bridge Road and down Bond Mill to the power lines, and along the back of the homes on Bauer Lane. WSSC has commissioned an updated survey and will notify West Laurel when it is completed. As soon as I know anything, I will pass it along to all of you.

Finally, many residents have asked questions about the various developments and requests to both Prince George's and Montgomery counties for zoning variances and water and/or sewer category changes. The WLCA has a long reputation for being proactive in this area. Last year we provided inputs into the Prince George's county updated Master Plan, participated in public hearings at the

state level, and provided letters in support of increased bicycle and pedestrian pathways. Laurel and Burtonsville along the Patuxent River are designated as "rural tier" or "rural residential" which in essence limits development to preserve Rocky Gorge Reservoir and the drinking water it provides to over 500,000 residents. Regardless of the project, the WLCA position has been consistent over time. The WLCA supports the current zoning regulations in both counties which govern development in the rural tier. Our concerns focus on the impact of development on the environment and Rocky Gorge Reservoir, traffic on existing roadways, and increased density on schools, police and fire. The outcome of several of the more recent hearings is still unknown. But as this area contains some of the few large tracts of undeveloped land, we anticipate increasing requests from developers. sibility of private citizens to take the law into their own hands. We should not be vigilantes. If you see a crime being committed, call 911. Do not try to apprehend a criminal yourself; even an innocent looking person may be carrying a hidden weapon. Let the police handle the situation. Our community officers are not on call 24/7, so please call 911, do not wait for Cpl. Beasock. If Cpl Beasock cannot be there, he will review the reports and get back to you.

Preventing crime is a partnership between police and citizens. Once

Proposed WLCA Budget 2011-2012

Each year the General Membership reviews and the votes on the annual budget. This year there have been small changes that include: setting aside \$1,200 for the annual membership drive which included letters to each household reminding them of their annual dues, creating a budget line for the Boy Scout donation (moving from miscellaneous), and reducing the Laurel Fire and Laurel Rescue donations to \$100 dollars each. As you can see, the largest cost is the printing and mailing of our annual *Hotline*. The WLCA collected bids from three printers and has selected the lowest bidder. To break even on the 2011-12 budget, we need to increase the number of households paying dues by 250 homes.
