## Spring General Meeting

A number of bills passed in the recently ended Maryland General Assembly session, including increased gas taxes, outlawing the death penalty, legalizing medical marijuana, and the offshore-wind energy incentive package. Others failed, including an effort to stop hydraulic fracturing, or *fracking*, which is used to release petroleum, natural gas, and other substances for extraction.

The May 16 General Meeting speakers will include Delegate **Heather Mizeur** from the 20th district in Takoma Park on the process of fracking and what it means to us in the state of Maryland. Members of the 21st delegation,

Senator **Rosapepe**, Delegates **Barnes**, **Frush**, and **Peña-Melnyk**, will provide a wrap-up of the recent session. And Councilwoman **Mary Lehman** will update us on Prince George's County.

I know that after reading much about County Executive **Rushern Baker's** proposal for the Prince George's County Schools System, I am eager to hear what our elected officials have to say on this topic, where they stand, and why. I am also hoping for an update on the new hospital system — where it is going to be located, whether Laurel Regional Hospital will close, and the timeline.

# West Laurel Housing Values

The news of the housing recovery is reflected in the West Laurel housing values! Home values remain inconsistent due to foreclosures and short sales that continue to impact the market. However, with record low inventories and mortgage rates, the market has shifted to a sellers' market, creating a significant increase in home values. The chart below shows home sales for the first quarter of 2013, and compares them to home sales for the same quarter of 2012. The good news is that the average sales price has increased more than 16 percent, with homes selling faster and for a greater percentage of their list price.

West Laurel homeowners can maintain and increase the value of their homes by taking these simple measures:

**Clean.** Clear out the clutter and donate junk you don't want or need anymore. A clean and organized home leaves the impression of one that is well-maintained.

**Maintain.** Keep up with your property. If you wait until it is time to sell, the cost of repairs

may be so much that you won't want to do it. Have your HVAC equipment, water heater and other systems in your home checked/serviced periodically.

**Kitchen.** This is the most important room in the house and where you'll get the greatest return for your investment. Update the appliances with Energy Star-rated appliances, change the paint and faucets, get new lighting, update the pulls on the cabinets, and even change the countertops.

**Bathrooms.** The same thing goes here as in the kitchen. If money allows, you can always update the toilet, vanity and flooring. If not, just change out the faucets, light fixtures (Energy Star) and paint.

**Exterior of the Home.** Clean your gutters regularly, replace rotting

alert; call 911 when things are not as they should be.

I'm delighted to share with you that at long last real estate seems to be moving in a positive direction in West Laurel. This month, West Laurel resident and Realtor® **Lenora Dernoga** has assumed responsibility for our regular column on housing values. Another great example of our community stepping forward.

After an extended period of time, the Bradford tree replacement program is moving toward its conclu-

sion. Finally, stumps are being ground and trees planted. There has been both positive and negative feedback on the new trees, with some neighbors delighted and others unhappy that a tree was planted where there had been no trees. Please note that the trees are technically in the county right-of-way, not your front yard. If you do not wish to have a tree planted, please contact the Neighborhood Design Center at 301-779-6010.

The ICC work continues. As prom-

ised after the last debacle, they are now providing regular updates to neighbors abutting the ICC work via door hangers and emails which are then reposted on the neighborhood discussion board. I encourage all of you to join the residents-only list.

The West Laurel Civic Association Board has been approached by two new development projects. The first is a small church at the corner of Brooklyn Bridge Road and Leo James Court. The second is for a commercial sports park at the intersection of 198 and Old Gunpowder Road. The WLCA Board has provided feedback to both developers to lessen the impacts on our residents.

WSSC has moved forward with their new rules for recreational usage of the watershed. As a reminder, you must have a permit if you boat, fish, hike, or horseback-ride. The WLCA continues to monitor this and work with WSSC as they continue to refine their regulations.

I look forward to seeing all of you at our upcoming **May 16** General Meeting. ❖



## Membership Campaign

**A**s we proceed toward the Spring General Meeting of the West Laurel Civic Association the WLCA Board is addressing a broad range of West Laurel quality of life issues affecting our residents.

In support of the WLCA, the number of dues-paying residents has increased from 400 for the 2010-2011 fiscal year to 590 for 2011-2012. Membership gains result from advocacy within the community for the quality of single-family-residence lifestyle we have been able to maintain since West Laurel was established.

## ICC Update

*Update provided by ICC Project Manager in April 2013*

The Maryland State Highway Administration's (SHA) contractor has removed approximately 610 feet of sound wall adjacent to Bradford Lane and Fitzpatrick Drive, which will be relocated to allow for the construction of the collector-distributor lanes along I-95.

The contractor has completed the necessary clearing and installation of erosion and sediment controls, including the temporary black silt fencing. The contractor has also placed fill (earth) on the site to create a stable ground area for the drilling equipment used to install caissons. Caisson (a caisson is a drilled shaft that is filled with

concrete for soil-retaining purposes in order to support the foundation of the sound wall) installation is scheduled through early-to-mid May.

Crews will then excavate and install the retaining wall (used to hold soil in place) on the community side of the sound wall. Once the retaining wall is in, new sound wall panels will be installed. This work is currently scheduled to continue into mid-to-late summer.



**Please be cautious when traveling near construction sites. For your own safety, please do not enter the construction zone at any time. Even when crews are not working, there are still hazards within the orange fencing. Additionally, please**

**talk with your children about the dangers of a construction zone and make sure they know not to play in these areas.**

# Zoning Update

The West Laurel Civic Association has a long history of proactive work protecting the zoning outlined in the Master Plans of both Prince George's and Montgomery counties. Each year this job gets more difficult as developers look toward the few remaining large tracts of open land. As noted in the President's column, two new projects have come forward since January. Here is a recap of what is currently happening in and around West Laurel.

**New** **A New Life Church of Christ** (*corner of Brooklyn Bridge and Leo James Court*)

This is a new project. The WLCA Board met with members of the church at the March board meeting. We recommended that the church reconsider the parking plan and relocate the church on the lot to create a bigger buffer for the houses that abut the property. The church is scheduled to return for the May WLCA Board meeting with an update. Nothing formal has been filed.

**New** **Sports Park** (*SW corner of Route 198 and Old Gunpowder Road*)

This is a new project. The WLCA Board met with Mr. Gudelsky and his team at the April board meeting. The project includes an outdoor playing field, in-



door playing field, and multipurpose building. The WLCA board is awaiting responses on hours of operation and parking requirements but was positive about the proposal. Nothing formal has been filed.

**Kingdom Hall of Laurel** (*Sweitzer Lane and Route 198*)

Work progresses on this project. The foundation has been poured, and sidewalks and roadwork are complete. The actual building is being erected by church members and has been delayed. Once it begins, it will be a very short process.

**Tommy's Shell Station** (*Route 198*)

No new updates. The Stormwater Management Concept plan has been submitted to the Prince George's County Department of Public Works and Transportation. The cover letter indicates the developers are proceeding with ten fuel pumps, and a 3,180 square-foot convenience store. The accompanying blueprint also shows the proposed car wash. After completing the Stormwater Management process, the developers will submit a detailed site plan and there will be a hearing where residents may provide testimony for or against.

**Eglise de Dieu** (*Route 198 and Riding Stable Road*), *formally known as Snowden's Birmingham Manor*

As of January 10th, the Mont-

gomery County planning staff is still working with the developer to revise the plans to meet the planning staff and Montgomery County Department of Transportation inputs. West Laurel will receive a copy of the revised plan when it is completed.

Again, there will be a formal hearing where residents may provide testimony for or against.



**Reaching Hearts** (*Brooklyn Bridge Road*)

No formal plans have been filed.

**Avalon Manor** (*Joyce Lane*)

After a significant lull in this project, it is now underway again with lots and homes for sale.

In addition to these projects in West Laurel, the WLCA is monitoring:

**Fairland Park** (*Old Gunpowder Road and Route 198*)

This development is moving forward in both Prince George's and Montgomery counties.

**Konterra** (*Old Gunpowder, Virginia Manor*)

No formal plans have been filed, but based on preliminary site work, the WLCA is monitoring closely.

**Burtonsville Master Plan.**

As reported in the last *Hotline*, the WLCA supports some elements of the plan and disagrees with others. The WLCA is monitoring the Montgomery County planning board for future work. ❖

## In Memoriam

**B**eth Evans, a long-time West Laurel resident and community volunteer, passed away on April 9th at her home. She was a formidable woman and a strong presence in our community. After her retirement from the Department of State, Beth helped fill her spare time by volunteering with the West Laurel Civic Association. She joined the Board and served as a passionate advocate for many programs in the community. Beth was a woman on a mission and heaven help anyone who stood in her way. As a result, West Laurel benefited.

She was the volunteer behind Dumpster Day—she convinced the county we should not have to make the 45-minute drive to the dump. It took more than a year to make inroads with Prince George's County bureaucracy, but she persevered.

Once she broke through, she annually scheduled the dumpsters with the county and reserved the parking lot with the Parks department. As a result, this past weekend we managed to fill several dumpsters without having to leave our own neighborhood.

Beth was also instrumental in our reinvigoration of Neighborhood Watch and our Community Policing efforts. She volunteered, ever so reluctantly, to serve as our community liaison. Under her leadership, our relationship with the Prince George's and Park Police flourished. Beth sponsored a tribute to First Responders, quarterly speakers including the FBI and Secret Service, and outreach to the children via Biking with Beasock. Based on the latest crime statistics, her efforts have made West Laurel

an extremely safe community.

Beth was engaged in good deeds outside of West Laurel as well. She was a leader of the Friends of Montpelier for many years, an active member of the National Association of Retired Federal Employees (NARFE), co-sponsor of the Prince George's County Police monthly Coffee for Seniors at the Laurel Senior Center, and a traveling ambassador for police efforts on Child and Adult Identity kits.

If the cause was righteous, Beth was there. From senior citizen requests to pleas for support for programs at Bond Mill Elementary School—she was there. As a friend and fellow volunteer, I and the community will miss her. West Laurel has truly lost a wonderful advocate for the community. May her memory be eternal. ❖
